 Alverson, Nathan F. Co. I 4th Regiment
 Promoted to Corporal. Was in siege of Yorktown and in
 battle of Williamsburg.
 Died at Davis Island June 1862

2.
 Babcock, Alfred D. Co. K. 154th Infantry. Private.
 Was in battles of Chancellorsville, Missionary
 Ridge and Look Out Valley. In service three years.

3.
 Battles Benjamin, Company C. 13th N.Y. Private
 No record of engagements but served until the close
 of the war.

4.
 Barlow, Russell L. Company K. 154th Infantry. Private.
 was in battle at Chancellorsville. transferred to
 invalid Corps, Served three years.

5.
 Bennett, William. Company K. 154th Infantry. Private.
 was in battles of Look Out Mountain, Chattenoga and
 Gettysburg. Was with Sherman from Atlanta to
 Savannah.

6.
 Bowers, Joseph. Company K. 64th Regiment. Died in hospital from
 wounds received at battle of Fair Oaks. Died June 1, 1862

7.
 Bullock, William J. Company B. 37th N.Y. Died in hospital at
 Newport, Va. from wounds received at Williamsburg.

8.
 Butcher, Andrew. Company C. 13th N.Y. Infantry. Private
 One year's service.

9.
 Butler, Ezekiel. Company K. 154th Inf. Private
 Served with Sherman's Army from Atlanta to
 Savannah and north through the Carolinas

10.

Camp Asa E. Promoted to Sargeant. Company B. 37th N.Y..
Was in battles of Williamsburg and Malvern Hill,
First Fredericksburg and Chancellorsville. Was
discharged and re-enlisted in Battery C. 13th
New York Field Artillery.

11.

Camp, Joel. Private Company B. 64th Regiment. One year
service and was discharged for disability.

12.

Camp, William. Private 194th New York Regt.. Son of Joel.
Stationed at Elmira and was not in any service.

13.

Carle, Jerome Private. Company K. 64th Regiment.
Confined for several months in hospitall
at Alexandria, Va. Served one year.

14.

Casten, William. Promoted First Sergeant and Lieutenant.
Company B. 154th Inf. Served from 1862 to close
of war. Was in battles at Rocky Face, Missionary
Ridge, and Sherman's Campaign

15.

Childs, John M. Company B. 154th Regiment. Wounded
in action at Chancellorsville.

16.

Clark, Edward W., Private. Company K. 64th Regiment. Drom
Major. Enlisted as drum major and was assigned to
Drum Major for regiment and served three years.
Was in battles at Antietam, Fredericksburg, Chancellorsville,
Gettysburg, wilderness and siege of Fredericksburg.

17.

Cooper, Nathaniel F.. Promoted. Company K. 64th Regiment.
Wounded in action. Was in battles at Fair Oaks and Gettys-
burg.

18.

Crofoot, Warren, Private. Company J. N.Y. Heavy Artillery.
Stationed all the time on Gun-boats.

19.

Darling, Marcellus W.. Promoted. Company K. 154th Inf.
Sergeant. Was in battles at Chancellorsville,
Look Out Valley, Missionary Ridge, Resaca.
Was with Sherman in his campaign to the sea.

20.

Dye, Alfred. Company K. 64th Regt. Was in battles at Fair
Oaks, Antietam, First Fredericksburg, Chancellorsville
and Gettysburg. Was shot thorough the lungs and died July
7, 1863 after two years of service.

21.

Dye, Charles, H. Company H. 100th Inf. Reg. Was a prisoner
at Fair Oaks and detained until Sept. 13, 1862.
Died from wounds and exposure in field
hospital Jan. 17th 1863.

22.

Dye, George W. Private. Company R. 9th Reg. Stationed in
Virginia, mostly on detail service.

23.

Earl, Charles L. Private. Company A. 11th Conn. Regt.
Was in battles at Newbern, Antietam and Fredericksburg.
Served in Sheridan's corps and was present at
Surrender of Lee at Appomattix.

24.

Fancher, William. Promoted Captain Company K. 64th Inf.
Elected Captain at organization of Company. Seen
service in regular army, and in Florida and
Mexican Wars. Was also in Marine service
on Pacific Coast. Taken sick invalidated
home only to die. Buried at Leon in Treat Memorial
Cemetery.

25.

Francis, George. Promoted Sergeant. Co. K 64th Inf.
Was wounded in action at Fair Oaks.

26.

Franklin, William S. Company K. 64th Inf. Died. Right leg ampu-
tated after battle of Fair Oaks. Died soon afterwards
in field hospital.

27.

Green, Benjamin F.. Private Company F. 194th. Regular.
Son of John C. Gree. No service

28.

Green, John C. Private. Company K. 154th Regiment. Was
with Sherman's Army in march from Atlanta to
Savannah and north through the Carolinas.

29.

Harmon, George W. Company D. 76 Reg. Was in bat le of
Spottsylvania. Wounded in action, at battle
of Cold Harbor. Recovered, then took action
at Petersburg, Weldon R.R. Was Taken
prisoner Oct. 1, 1864 and sent to Salsbury where he was
detained until March 1, 1865. Returned home and died in
town of Leon and was buried in Treat Memorial
Cemetery.

30.

Helker, Frederick. Private Company B. 64th Reg.. Enlisted at
Randolph. Was in battles at Fair Oaks and Seven Days
Retreat.

31.

Hogan, Roger C. Company K. 64th Reg. Was in battle of
Fair Oaks and killed in action at Antietam.
Two years service.

32.

Hulburt, Levi. B. Company K. 64th Inf. Reg. Died in Hospital
at Harpers' Ferry.

33.

Hunt, Horatio N. Company K. 64th Inf. Promoted to Captain. Enlisted as lieutenant and was promoted to Captain July 24, 1862. Engaged in battles at Fair Oaks, Gains Mills, Fredericksburg and served until the close of the war. Died at Leon and is buried at Leon.

34.

Hurd, David H. Company H. 37th Inf. Promoted to Corporal. Engaged with his company and regiment in battles at Williamsburg, Fair Oaks and Malvern Hill

35.

Ingersoll, Francis. Company K. 64th Inf. Promoted Corporal. Was in battles in Fair Oaks, Gains Mills, Malvern Hill and Spottsylvania. Wounded in the battles of Fair Oaks and Spottsylvania. Taken to Craney Island and died soon after.

36.

Ingraham, Charles M. Company K. 6th Reg. Wounded in action at Gettysburg.

37.

Ingraham, Henry A. Company K. 64th Inf. Died in hospital at Alexandria.

38.

Ingraham, Simeon M. Company K. 64th Reg. Promoted to First Sargeant Was in battles at Fair Oaks, Gains Mills, Antietam, Gettysburg and Spottsylvania. Was wounded in last two battles.

39.

Jones, David S. Promoted to Corporal. Company K. 154 inf. Was in battles at Chancellorsville, Gettysburg and with Sherman's campaign to the sea. Was wounded in action at Gettysburg.

40.

Klearstead, William P. Company K. 64th Inf. Promoted, to sargeant. Was in battles at Fair Oaks, Gains Mills, second Bull Run, First Fredericksburg. Made prisoner in Libby Prison, said to be the worst prison kept by the confederates during the war and in which more lives were lost by starvation and exposure than in any other prison in the South. He was transferred to Salisbury where he died from disease contracted at Libby Prison.

41.

Kyser, Amos S. Promoted to corporal. Company K. 154th Reg. Was in battles of Chancellorsville, Look Out Mountain and Missioary Ridge.

42.

Milliman, John H. Company K. 64th Reg. Was wounded in action at Gains Mills.

43.

Moore, Harlan E. Company K. 64th Reg. Was wounded in first battle at Fredericksburg, and killed in battle at Chancellorsville. It was said, his last shot brought down a rebel. He died May 5, 1863.

44.

Mosher, Frances M. Promoted to Sargeant. Company B. 64th Reg. Was in battles at Antietam and First Fredericksburg.

45.

Mosher, John. Revolutionary. Was with General Herkimer in Mohawk Campaign. Came to Leon in 1830 and lived in eastern part of the town, near Kendall section; known at that time as Pleasant Grove. Was a pensioner. Died in Leon and buried in Kendall Cemetery. Pension gives Massachusetts Service.

Wickerson, Harris. Company H. 37th Reg. Wounded in action at Charles City.

47.

Northup, Charles. Company K. 64th Inf. Died in hospital at Elmira, N.Y.

48.

Noyes, Dudley. Revolutionary Revolutionary. Entered service at Dedham, Mass. Was in Washington's Army. Took part in battle of Bunker Hill. Came to Leon in 1828 and died 1833. Pension. Wife Sally.

49.

Park, Andrew C. Company B. 154th Reg. Promoted to First Sergeant. Was in battles of Antietam and Fredericksburg.

50

Pember, Delos E. Company K. 64th Reg. Wounded in action at Fair Oaks.

51.

Flopper, John C. Company B. 64th Reg. Was in battle of Fair Oaks, wounded in action and taken prisoner during seven days retreat.

52.

Ross, Reuben. Company B. 64th Inf. Died in hospital at Fort Monroe.

53.

Safford, James M. Company K. 64th Inf. Died in hospital at Fort Monroe.

54.

Shannon, Marshall H. Company K. 154 Reg. Wounded in action at Fair Oaks .

55.

Shannon, Trumaf. Company K. 154th Reg. Was in first battle of Fredericksburg and killed in action at Chancellorsville.

56.

Shelmaline, Borut D. Company K. 154th Reg. Was in first battle of Fredericksburg and killed in action at Chancellorsville.

57.

~~Shannon~~^{Sherman}, Joseph P. Company A. 64th Reg. Wounded in action at Fredericksburg.

58.

Squires, Ambrose. Revolutionary. Came to Leon in 1824, from New Hampshire. Was in Washington's Army was a pensioner.

Note: received pension from Onondaga County.

59.

Wellman, George W. Company K. 64th Reg. Wounded in action at Fredericksburg.

60.

Wells, Albert N. Company K. 69th Inf. Died in hospital at Fort Monroe

61.

Whitcomb, Samuel. Came from New London, Conn. Was in that city when it was burned by British under General Arnold. Died and was buried in Leon in 1840.

62.

Wood, Bradford H. Company K. 64th Reg. Wounded in action at Chancellorsville. Wound was severe but he remained in the service until the end of the war.

63.

Wood, Daniel T. Company K. 64th Reg. Promoted to Sergeant. Right arm shattered at Gettysburg. Was in battles at Gains Mills, Antietam, Centerville, Fredericksburg, Chancellorsville and Gettysburg

64.

Zibble, Jefferson. Company F. 64th Reg. Died in hospital at Gettysburg.

65.

Bigler, Nicholas. Records show he served under General Herkimer in the Mohawk campaign, was at Criskany when Herkimer fell and was taken from the field only to die from his wounds. Mr. Bigler died in 1864, at the outbreak of the rebellion.

66.

Day, Anthony. Mr. Day entered the service at Danbury, Mass. He came to Leon in about 1830 and lived on the south part of lot number 33 on the town line road. He was a pensioner and died in 1842 and was buried in Leon. Descendants of Mr. Day still live in Leon.

67,

Franklin, James. Entered the service of the Revolution from Chelsea, New Hampshire under General Warren. Was in the battle of Bennington and came to Leon in 1829 and built the first house in the Township on lot 50, Riga Road, the last occupant of the place being Andreas Gale, a descendant of Mr. Franklin. There is no house on the place at this writing. Mr. Franklin died in 1834 and is buried in the cemetery he founded at "The Hollow" on lot 50.

68.

Freeman, Elisha. Enlisted from Saratoga County, N.Y. Was in the campaign against Burgoyne in Washington's army. Was a pensioner and died in 1840 and is buried in Leon.

69.

Sherman, Joseph P. Company A. 64th Regiment. At Fredericksburg.

Eldridge, Andrew J. Sergeant Company K. 64th Inf, Was in the battles of Fair Oaks Seven days retreat and Gains Mills.
