PROPOSED CHARTER OF KENANSVILLE NAVAL STORES COM-PANY, INCORPORATED

The undersigned hereby associate themselves together for the purpose of becoming incorporated under the laws of the State of Florida and under the terms on the following prop sed charter:

ARTICLE I

The name of this corporation shall be KENANSVILLE NAVAL STORES COM-PANY, INCORPORATED.

2. The principal office and place of business shall be in the Town of Kenansville, County of Osceola, State of Florida, and its business may be conducted in said Town of Kenansville or elsewhere in the State of Florida, or in any other of the states of the United States, or in any other countries through such offices, beauches. countries, through such offices, branches, agencies or otherwise as shall or may be necessary or convenient.

ARTICLE 2.

1. The general nature of the business or businesses to be transacted by said Com-pany shall be as follows:
