Enlisted September 2, 1862 from Cattaraugus County, State of New York and was mustered into the U. S. Service at Jamestown, N. Y. September 24, 1862 as a Private for a term of 3 years in Co. G 154th Reg. N. Y. Voluntary Infantry, under Capt. M. B. Cheney and Colonels A. G. Rice and P. H. Jones. The Regiment was assigned to the 11th Corps. Army of Potomac to October 1863 and Army of Cumberland till April 1864, then 2nd Brig. 2nd Div. 20th Corps Army of the Cumberland and Comrade Wing shared the fortunes of his regiment in all of its movements & operations and engagements during his service including the Mud March, January 20-24, 63 - Battle of Chancellorville, May 1 - 4,63 - Battle of Gettysburg, Pa., July 1 - 3, 63 - was CAPTURED July 1, 1863 taken to Richmond, Va. - was PAROLED - sent to Annapolis, Md. - rejoined his Regiment at Lookout Valley, Tenn. - Battle of Wauhatchie, Tenn.
