DEATH OF A PROMINENT CITI. 1895 ZEN OF OTTO.

Dr. S. V. Pool Called Away in the Prime of Life. 92 Dr. S. V. Pool died at his home in Otto Friday morning, Oct. 18th. He had not been in good health for some time, but the fatal illness was only of about a week's duration. The disease was of a neuralgic character, and centered at last at the heart, and the most vigorous measures of the attending and counselling physicians could not break its hold. Dr. Pool was born at Springville, N. Y., March 14, 1837. He was a graduate of the Springville Academy, and the Buffalo Medical College, and attended lectures at the Jefferson Medical Col-He located in lege in Philadelphia. Otto in 1867, and became one of the most succesful medical practitioners in the

county. Dr. Pool was a veteran of the war of the rebellion, having enlisted in the 154th-Regt. N. Y. Vols., in September, 1862. He was commissioned as First Liutenant of Co. B, and participated in the battles of Chancellorsville and Gettysburg. With a large part of the regiment. he was taken prisoner at Gettysburg, and was confined successively in rebel prisons at Libby, Macon, Ga., Charleston, S. C., and Charlotte, N. C. After an imprisonment of 20 months he escaped from the prison at Charlotte, and after four weeks of hiding in the woods and wandering in the Blue Ridge mountains, succeeded in reaching the Federal lines at French Broad River, 80 miles above Upon reaching the Knoxville, Tenn. Union army he went immediately to Washington and reported for duty.

Dr. Pool was a life long republican, and was honored by his party by an election to the board of supervisors for three terms, and to the assembly of the state for the years 1878-9. He was a legislator who stood high in the esteem of his colleagues, being a man of broad intelligence and unswerving integrity.

He leaves a widow and two children-Dr. Bret Poole, a successful medical practitioner in Lowell, Mass., and Mrs. Mark Bensley of Buffalo.

The funeral was held on Sunday at i p. m. in the Congregational church at Otto, Rev. Johnson, a former pastor of the caurch, officiating. The bearers were colleagues of the deceased in the County Medical Society.

Dr. Pool's death will be widely mourned by those who highly regarded him as a man, and a physician of skull and sound judgment.

Sunday morning, Mrs. Wilson, mother of Mr. E. O. Wilson, with whom she made her home, was found dead in her bed. She had retired the previous evening apparently in usual health. She had seen the vanishing away of ninety years and three months when the summons came that called her hence. The funeral services were held on Tuesday at the residence of Mr. Wilson, and the remains were taken to a cemetery in the town of Mansfield and there deposited. 1594
